I hope you're enjoying your summer and staying well. This month, Governor Green finalized his list of vetoes and signed 313 bills into law. While I was disappointed to see the veto of HB958, a bill to strengthen e-bike regulations, due to constitutional and clean energy concerns raised by the administration, I know this remains a top priority for our community, and it's one I'll keep fighting for next session.

On a brighter note, I'm thrilled to share that **HB1231**, one of my bills, was signed into law! Now Act 212, this law establishes the **largest dedicated funding source for the Safe Routes to School program,** and in our district, we're advocating for much-needed improvements near **Mililani High School** along Mehe'ula Parkway and **Kipapa Elementary School** by Kuahelani Avenue, where increased speeding has become a growing community concern.

🛠 2025 Hawaiʻi's Legislative Session Highlights

This year's session (Jan 15 – May 2) was marked by meaningful progress in climate resilience, disaster preparedness, education, and public safety. Here's a snapshot of significant laws enacted:

 ACT 243 (HB1483) Stricter Fireworks Regulations

 Increases penalties and speeds prosecution of illegal fireworks offenses to boost public safety.

• ACT 96 (SB1396) Green Tourism Fee

 Increases the Transient Accommodations Tax (TAT) from 9.25% to 10% for hotels and resorts, and extends this to cruise fares, making Hawaii the first state to link this new revenue directed toward climate change mitigation, natural resource protection, and sustainable tourism projects.

• ACT 139 (SB1300) Expanded Free School Meals

- Extends free meals to qualifying DOE students in FY2025–26, and expands access to families earning up to 300% of the federal poverty level the following year.
- ACT 310 (SB933) Nonprofits Funding
 - Provides \$50 million in state funding to help Hawai'i nonprofits continue delivering essential services like health care, child care, housing, and homelessness support in light of major federal funding cuts.

• ACT 296 (SB1044) Hurricane Relief Fund Reinstatement

 Reopens the Hawai'i Hurricane Relief Fund to back up the private market during insurance shortfalls, creates a condo loan program to help associations address deferred maintenance, and strengthens state oversight and reinsurance tools to stabilize Hawaii's property insurance market.

• ACT 301 (HB1001) Maui Wildfire Settlement Trust Fund

 Creates the Maui Wildfires Settlement Trust Fund and commits \$807.5 million over four years to provide timely compensation to victims of the 2023 Maui wildfires as part of a \$4 billion multi-party settlement.

• ACT 302 (HB1064) Fire Safety & Fire Marshall Reform

 Creates the Office of the State Fire Marshal to lead wildfire prevention and response statewide, enforce fire safety standards, coordinate across agencies and implementing key recommendations from the Maui fire investigation.

Building a Better Path to Success!

Gov. Josh Green Signs Law for Safe Routes to School I'm thrilled to share that my bill, HB1231, now Act 212 was signed into law on June 25, 2025! This landmark measure create the largest dedicated funding source for the Safe Routes to School program, supporting critical infrastructure like raised crosswalks and flashing beacons to help students walk, bike or roll to school safety.

Advocates are calling it the "Biggest Legislative win for transportation equity in 2025" and I'm grateful to all who submitted testimony!



New Laws for Our Keiki!

On July 7, 2025, Governor Josh Green signed Act 297 (HB613) into law, **making the Safe Spaces for Youth program permanent.** This program provides shelter, meals, healthcare, education, and job training for homeless youth across all counties in Hawai'i. The Legislature appropriated nearly \$2.7 million over two years to support the program - a major step toward breaking the cycle of homelessness and uplifting our most vulnerable young people.



MILILANI MAUKA PHASE 24 ROAD REHABILITATION



Starting July 2025, a 16-month road rehabilitation project will begin in Mililani Mauka to enhance local streets. Work will take place Monday–Friday, 8:30 AM– 3:30 PM (excluding holidays), with lane closures, detours, and no parking in designated areas – violators will be towed.
